## CURRICULUM

### CORPORATE STRUCTURES IN ASIA

#### SYLLABUS

Comparison of various structures, due diligence, structuring a deal taking into accounts tax, IP, HR and other relevant factors.

#### OBJECTIVES AND SKILLS TARGETED

This course will allow attendees to understand and evaluate the pro and cons of setting up different types of legal entities (wholly-owned enterprise, joint venture, representative office and/or branch) across various jurisdictions in the region using different case studies.

### INTERNATIONAL CONTRACTS

#### SYLLABUS

This course covers the legal and contractual scope and treatment applicable to international contracts.

#### OBJECTIVES AND SKILLS TARGETED

Attendees will acquire in-depth knowledge of the legal and contractual mechanisms governing the conclusion and performance of international contracts.

### PROJECT FINANCING

#### SYLLABUS

The Characteristics of banking law at the international level as they pertain to project financing.

#### OBJECTIVES AND SKILLS TARGETED

Acquiring knowledge of international project financing rules and practice (syndicated loans, guarantees, financing of different assets, other project financing).
