All participants will benefit from the experience of highly respected international academics and practitioners within the international arbitration, investment arbitration and dispute resolution sectors, and with diversified and complementary roles (full-time law professors in France or from foreign countries, lawyers, international arbitrators, quantum experts, third party funders, etc.).

CURRICULUM – 302 HOURS OF TEACHING –

Format: Lectures are taught in Paris from mid-September to April.

COURSES

Courses have been designed :

- ▶ To master the fundamental elements and peculiarities of both international arbitration and investment arbitration;
- ▶ To broaden the understanding of arbitration from a comparative perspective, including with other dispute settlement mechanisms;
- ▶ To become more familiar with the substantive and international aspects of certain legal regimes (international contract law, protection of foreign investments, etc.);
- ▶ To acquire the indispensable knowledge from international arbitration and litigation practitioners (drafting clauses, briefs, pleadings, evidence, examinations and cross-examinations, establishing the quantum of damages, etc.);
- ▶ To understand the functioning and distinctive features of the main arbitration centres and their rules.

All courses are delivered in English and taught by highly recognised academics and international practitioners.

WHAT ARE THE STRENGTHS OF THE LL.M. AWArDS?



"The LL.M. AWArDS, which is held entirely in English and is devoted to international (commercial and investment) arbitration and the settlement of international commercial disputes, is an ideal combination of lectures given by academics specializing in arbitration or international litigation, as well as experienced and renowned practitioners. With the support of this high-quality teaching team, the lectures will be divided into core courses on arbitration, specialization courses, including courses on some of the major sectors involved in international

arbitration and dispute resolution, elective courses and practical workshops.

Offered in Paris, the historical heart of the development of international arbitration, in close proximity to the main European arbitration institutions, to the best practitioners and specialized academics who have contributed to the worldwide reputation of international arbitration and its law, the LL.M. will also rely on the contribution of foreign academics and practitioners, in particular through various conferences."

GOALS

The course is based on an optimal blend of academic and practical knowledge, combining lectures, case studies and tutorials with group work. It is aimed at providing students and professionals working internationally with the required combination of legal and practical skills to ensure good and efficient management of international and investment arbitration, as well as other dispute settlement methods.

TUITION FEES & DEADLINES

Academic year: September 2024 – April 2025

ENTRY REQUIREMENTS

The course is open to advanced students and to lawyers seeking to increase their knowledge and strengthen their skills in international arbitration and international business dispute settlement in an international environment.

LL.M. FEES

Tuition fees: EUR 20,000.

This amount does not include transport, food or accommodation.

LL.M. AWArDS APPLICATION DEADLINE

The application process will start on December 1st, 2023 and close on April 28, 2024.

APPLICATION DECISION
