Educational System

The Mauritian education system is modelled after the British system and is divided into primary, secondary, and tertiary levels. The government places a strong emphasis on education, resulting in a literacy rate exceeding 90%. English is the primary medium of instruction, but French and Creole are also widely spoken, providing a multilingual environment that can enhance your language skills.



Cost of Living

Many students opt for shared housing or university dormitories to reduce costs. 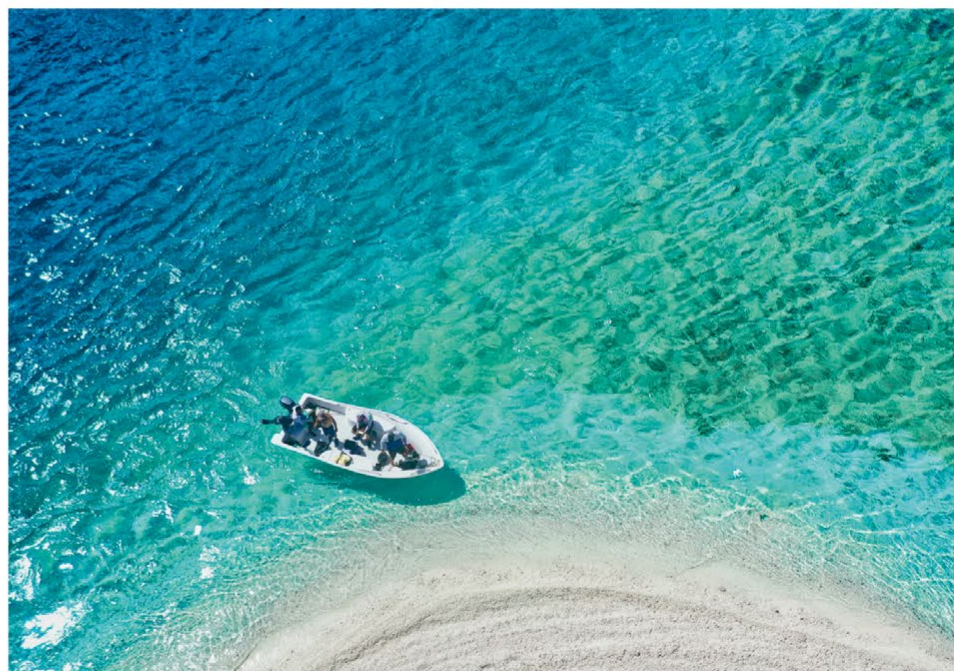
Safety and Healthcare

It prepares students and professionals for operations such as large acquisitions or market transactions, cross border mergers, complex financing, restructuring, LBOs, financial engineering, and industrial projects. APPLICATION REQUIREMENTS

ADMISSION CRITERIA

Candidates will be selected on the basis of their academic records and following an assessment of each candidate's suitability for the course.

APPLICATION PROCESS

Applications are to be submitted online via the following platform:

APPLICATION DECISION

Candidates will receive a reply within 15 days of reception of their completed application.

TUITION FEES

Undergraduate programmes: 6,500 EUR per academic year.

LL.M. International Business Law: 12,000 EUR

OTHER MANDATORY UNIVERSITY FEES

Campus Life Fees | Mauritian and International students: approx. 75 € per academic year.

VISA PROCESSING FEES

International Students only: approx. 260 € - The exact amount will be communicated to the student during the visa application process.

DELIVERY MODE

Undergraduate programmes are delivered on a full time basis. The LL.M. has evening classes with flexible delivery to accommodate professionals.

STUDY METHOD

A hybrid way of study is currently in place with both face-to-face as well as online classes. When possible, a majority of classes are being conducted on-campus - including online classes which students must attend from the campus.

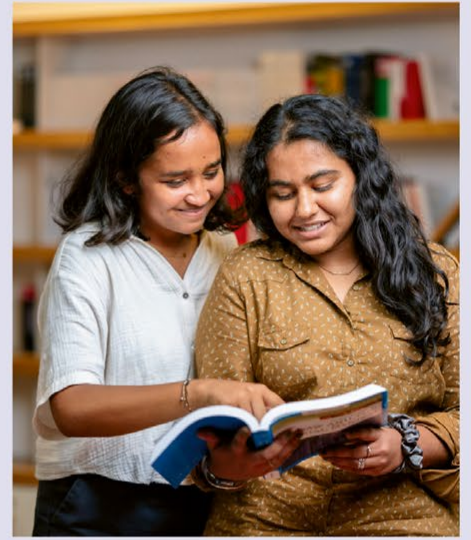
